**ARTICLE 1
PURPOSE AND OBJECTIVES**

- (1) This agreement in this Implementation Arrangement intends to set out the general principles of mutual cooperation in the field of academic mobility and educational capacity development, according to which the above agreed institutions may jointly identify areas of mutual interest and carry out cooperative activities on the basis of mutual benefit
- (2) The purpose of this Implementation Arrangement is for Virtual Summer Course Program.
- (3) The objectives of this program is for facilitating both Parties on Teachers' Training outside

- (4) SEA-Teacher Student Exchange Programme is in the context of implementing an academic and global campus needs

ARTICLE 2 WORK IMPLEMENTATION

- (1) The activity is carried out around August or September 2023
- (2) The SEA-Teacher Student Exchange Programme is carried out offline and the place of activity is prepared by both parties.
- (3) Number of Inbound Students both parties five (5) and Number of Outbound Students both parties five (5).

ARTICLE 3 FINANCING

The cost of cooperative activities may be funded as mutually determined. All cooperative activities under this Framework of Cooperation (FOC) will be subject to the availability of funds to the above agreed institutions.

ARTICLE 4 TIME OF WORK IMPLEMENTATION

- (1) The period of this Implementation Arrangement since the signing of this Implementation Arrangement is up to 30 days after the SEA-Teacher Student Exchange Programme from Universitas Lampung, Indonesia to Guimaras State University, Philippines.
- (2) The activity report is completed a maximum of 30 days after the completion of SEA-Teacher Student Exchange Programme
